- 1) The Continuation / Extension of Affiliation is issued for the Academic Year 2022-2023 subject to the permission of National Commission for Homoeopathy/Central Council of Homoeopathy, New Delhi/Govt. of India/Department of AYUSH, New Delhi and if the permission is declined by the said authorities this Continuation / Extension of Affiliation shall be treated as cancelled. The college is not authorized to admit the students for 1<sup>st</sup> year of the course until receipt of permission of the National Commission for Homoeopathy, New Delhi/Govt. of India/Department of AYUSH, New Delhi.
- 2) The admission shall be done only through the Competent Authorities.

With reference to the above cited subject, and referred letter the undersigned is directed by the competent authority to convey as under:

“The college submission as appeal has been carefully examined by the Commission and observations are as under:

1. MUHS vide letter no. MUHS/XA/5908/2022 dated 25/08/2022 has declared Holiday for Teaching staffs and Students only thus, hospital must have been functioning even during holidays however, IPD was closed.


**Overall observations:**

1. Based on the submission made by Principal, Gandhi Natha Rangaji Homoeopathic Medical College and Hospital, 13, Budhwar Peth, Jain Boarding Campus, Balives, Solapur – 413011, Maharashtra on 2.12.2022, the documents have been carefully examined as per the provisions of the Homoeopathy Central Council (Minimum Standards Requirement of Homeopathic Colleges and attached Hospitals) Regulations, 2013 amended time to time and it is observed that the college could not justify the closure of hospital during holidays although other deficiencies have been rectified.
2. Now, THEREFORE, the Commission has decided to issue conditional permission for 1<sup>st</sup> BHMS with intake capacity of 50 UG seats for Gandhi Natha Rangaji Homoeopathic Medical College and Hospital, 13, Budhwar Peth, Jain Boarding Campus, Balives, Solapur – 413011, Maharashtra for the academic session 2022-23.
3. All admissions in Under Graduate (BHMS) course shall be through ‘National Eligibility Entrance Test (NEET)’ only. Any admissions carried out other than NEET qualified students will not be approved by the Medical Assessment and Rating Board for Homoeopathy as per rules and will invite penalty as may be decided will be imposed.

4. The counselling for 15% seats under All India quota shall be conducted by respective counselling Authority of State/ UT Government as designated by the Central Government and counselling for the remaining 85% seats or as the case may be, shall be conducted by the concerned Counselling Authority of that State / UT. 100% Under Graduate seats of the permitted intake capacity shall be treated as all India quota for Deemed University as they are All India in nature. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Government for All India quota or the student admitted there under. The category wise list of students admitted shall be informed to the Medical Assessment and Rating Board for Homoeopathy immediately after the process of admission is completed.
5. Accordingly, the college representation dated 2.12.2022 to Commission against order of MARBH vide letter dated 15.11.2022 stands disposed of.
