Sir,

Gandhi Natha Rangji Homoeopathic Medical College, has applied for permission for sanction of BHMS course with 50 seats and Applied for increase of intake capacity of UG seats from 50 to 100 for the academic year 2025-26. The College has submitted the Part I information in which the entire functional profile has been narrated, MARBH conducted inspection on 27.05.2025 & 28.05.2025, followed by hearing on 24.06.2025. The Medical Assessment and Rating Board has examined the College as to whether the college fulfils the Minimum Essential Standards as per the prevailing regulations under clauses 26 and 28 of the NCH Act 2020. On careful examination of the report, the Medical Assessment and Rating Board observed the following shortfalls:-

**1. Deficiency of Teaching Faculty: (07 Deficiencies)**

- i. In Department of Anatomy 1 Professor is deficient.
- ii. In Department of Physiology 1 Professor is deficient.
- iii. In Department of Homoeopathic Materia Medica 1 Associate Professor & 1 Assistant Professor are deficient.
- iv. In Department of Surgery 1 Assistant Professor is deficient.
- v. In Department of Community Medicine 1 Assistant Professor is deficient.
- vi. In Department of Repertory 1 Professor is deficient.


**2. Miscellaneous:**

3. Considering the above observations during inspection and hearing, MARBH has decided to issue permission to Gandhi Natha Rangji Homoeopathic Medical College, 13, Budhavar Peth, Jain Boarding Campus, Balives, Solapur- 413002 for continuing UG (BHMS) course with intake capacity of 35 seats (reduced from 50) for academic year 2025-26.
4. MARBH has decided to give denial to the college for their Application for increase of intake capacity of UG seats from 50 to 100 for the academic year 2025-26.
5. All admissions shall be made from NEET qualified candidates only. It is further informed that minimum 15% of seats of the permitted intake capacity of (35 seats) BHMS course shall be treated as All India Quota. Counseling for seats under All India Quota shall be conducted by Central Government and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned counseling authority of the state/UT designated by Central Government. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Government for All India Quota or the student admitted thereunder.
6. The Category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET qualified students will not be approved by the Medical Assessment and Rating Board.
7. If the College is aggrieved by any decision of the Autonomous Board, college may prefer an appeal to the Commission against such decision within 30 days of the communication of such decision as per National Commission for Homoeopathy (Assessment and Rating of Medical Institutions) Regulations 2024, section 14 subsection (1) and NCH General Regulation 2023 section 22. The Manner of instructions for appeal are attached.
